350 lb Tool Cart used for strong and transporting hand tools or the like. The top side work surface slides horizontally to open the storage compartment directly below. This storage compartment coupled with the additional 2 tool drawers gives the user plenty of tool storage with ease of mobility.

OPERATION

- 1. Sliding top must be open in order to open the tool drawers. Close sliding top to lock two drawers.
- 2. Only one drawer can be pulled out at a time.
- 3. Load capacity: 350 lb (158 kg)

ASSEMBLY INSTRUCTIONS

- 1. With the tool storage box upside down, attach legs at the four corners with the supplied hardware.
- 2. With the system still upside down, attach base to the opposite side of the four legs with the supplied hardware.
- 3. Rotate the assembly on to one side making the legs point parrallel to the ground.
- 4. Attach casters to the bottom of the frame with the supplied hardware. (Note: casters w/lock-2 pos. item 13)
- 5. Rotate the assembly upright.
- 6. Ensure that all fasteners are tight.




Figure 1 - Assembly Parts Breakdown
